EU/Late Payments: Commission urges four Member States to comply with the Late Payment Directive to protect SMEs in their commercial relations.

On 15 February 2017, the Commission has taken action against four Member States who are not implementing the Late Payment Directive. The Members States are Greece, Italy, Slovakia and Spain. These four Member States have two months to take measures to comply with the Directive. If not, the Commission could decide to take the Members to the European Court of Justice. The Late Payment Directive was implemented in 2013. The Directive has put time limits in place for payments by companies and public authorities when producing goods and services. In B2B transactions the time limit was set at 60 days unless expressively agreed upon otherwise. This Directive gives businesses the right to compensation when payment deadlines are not met. On 26 August 2016, the Commission adopted a report on the implementation of this Directive. The report stated that the implementation overall is positive but that further enforcement of the Directive is still needed.

EU/Environment: The Commission announces the creation of the Circular Economy Platform.

On 2 February 2017, Commissioners in charge of the Circular Economy Package announced the creation of a new platform meant at encouraging and enhancing investment in circular economy projects. Vice-President Katainen highlighted the creation of a Circular Economy Finance Support Platform with the European Investment Bank which will be use to match investors with innovators. The new platform is meant to encourage new form of financing required to enhance innovation in the Circular Economy. It will reinforce the link between already existing instruments such as the EFSI and the InnovFin-Eu Finance for Innovators which should allow for the development of new financial instruments for circular economy projects.

EU/Digital: Agreement reached between the Institutions for the modernisation of EU copyright rules

On 10 February 2017, negotiators from the Parliament, the Council and the Commission announced that they have reached an agreement to modernise existing EU copyright rules. The new rules would allow European to access and fully use their online subscriptions when travelling within the EU. The deal has been endorsed by Coreper. The next step in the legislative process will be for the Council of Ministers and the European Parliament to formally adopt the proposal before it can enter into force, which has been foreseen for 2018.

EU/Digital: The Commission launches a new study targeting barriers for SMEs in the Data Economy.

On 17 February 2017, the Commission launched a new study on the emerging barriers to the free flow of data including issues of data ownership, interoperability, (re)-usability and access to data, and liability. This study aims at providing evidence and analysis for the EU Free Flow of Data Initiative. In parallel to this study, the Commission is also carrying a public consultation to gather stakeholder feedback and identify key challenges faced by businesses in the Digital Single Market. Both initiatives aim at finding solutions on removing barriers when sharing or accessing data, reducing the costs born when sharing data and enhancing the benefits deriving from data sharing. EU/Digital: The Council agrees on a proposal to fight cross-border infringements to EU consumer protection laws.

On 20 February 2017, the Council adopted a general approach to increase cooperation between national authorities responsible for the enforcement of consumer protection laws. The aim of the proposal is to further decrease the negative effect cross-border infringements to EU consumer law has on consumers. The proposal sets out to increase harmonisation between the different public enforcement authorities to ensure early detection, investigation and cessation of intra-Union infringement. This will be done by setting a number of minimum investigation requirements and enforcement powers that every national authority will have to be able to execute properly to ensure an effective fight against infringements.

EU/Trade: CETA can benefit the European economy.

On 20 February 2017, Artis Pabriks, Parliament's lead MEP on CETA, outlined the many benefits the free-trade agreement with Canada could have for the European economy. CETA will allow SMEs to access the Canadian market which was previously out of reach for them because of tariff and non-tariff barriers, moreover the deal will boost wealth and enable national governments to better assist their citizens in need. With the support of the EU Parliament and of the Canadian Parliament, CETA will enter into provisional application, allowing Member States to see firsthand the positive effect the deal will have on the economy before they have to ratify the agreement in the upcoming years to allow for its full implementation.

Public consultation on the functioning of mutual assistance between EU Member States for the recovery of taxes

DEADLINE: 08/03/2017

The competence of tax authorities is limited to their national territory. They cannot take recovery actions in other countries, although tax debtors may have moved to another country or may dispose of assets in other countries. Therefore, the EU has adopted legislation which allows the EU Member States to provide mutual assistance to each other, for the recovery of their taxes. The European Commission is currently undertaking an evaluation of this legislation, as announced in its Action Plan on value added tax (VAT). This public consultation seeks the opinion of persons confronted with such recovery assistance procedures and other stakeholders.
